Communication to BC Athletics Committees & Working Groups

To advance operational efficiency and clarify issues of governance and leadership, the BC Athletics Board of Directors is considering changes that would alter our existing committee structure and governance. The changes are proposed to come into effect on September 1, 2024.

The Board of Directors would, going forward, strike committees on an as needed basis to support the development of organizational policies. Thus, there would no longer be any traditional standing committees and any formed committees would be accountable to the Board of Directors only.

Much of the other valuable work that volunteers on our committees have previously done would be done by staff or by volunteers on working groups under the direct supervision and guidance of the BC Athletics CEO and Staff.

By implementing these changes, our goal is that BC Athletics can improve operational efficiency and better value the expertise, experience and time invested by our members and sport community in ways that best support the collective vision and mission of BC Athletics.

The proposed changes respond to feedback from committee members, staff and BC Athletics members at large who have commented on the lack of direction and leadership experienced within the existing committee structure. That structure, created to support a much smaller organization, hasn't been updated as the organization has grown over time.
