

# MINUTES OF THE 2021 BC ATHLETICS ANNUAL GENERAL MEETING HELD VIRTUALLY ON AUGUST 21, 2021 BY RINGCENTRAL MEETINGS FOR REMOTE DELEGATE REGISTRATION AND VOTING

Virtual check-in for Delegates was opened at 10:00am.

### 1. CALL TO ORDER

- The meeting was called to order at 11:02am with Board Chair, Greg White, as the Chair. (*Refer to Addendum "A" for a list of the delegates in attendance*).

### 12. SPECIAL PRESENTATION - 2022 & 2023 Athletics Canada National Track & Field Championships - Brent Dolfo

- a. To be held June 23, 24, 25 and 26, 20022 at McLeod Athletic Park in Langley
- b. Combined Championships to be embedded in the National championships as well as Para Athletics championships.
- c. In the process of adding race walk, likely to be held at the Mission Raceway, which could push the date to June 22, 2022.
- d. Meet will also be qualifier for Canada for the Wold Championships in Eugene later in the summer.

- e. Last National Championships held in BC was in 2004. Hoping that all the Clubs will join in terms of volunteering and opportunities for younger athletes.
- f. Striving to continue to make the championships free for those under 12.
- g. Hosting championships is the best opportunity to get the local government to upgrade the facilities. Have been able to do that again but do have a few issues to iron out, but making good progress.
- h. It was asked if there will be marketing and communications for volunteering? Brent noted, yes, Harry Jerome had an online sign up system. Looking to put something similar in place and providing links to the clubs.
- i. Brent offered for anyone to reach out to him if they has any other questions.
- j. Brian noted they were continuing to work with the organizing committee and facilities and expect things to move ahead well.
- k. Chair thanked Brent and the Committee for their work and noted it was a great venue for the event. The host committee has a history of putting on good events for the sport and believe the athletes are looking forward to competing. Glad there's an opportunity to host these events.

    - 2. Report references several things:
      - a. Facilities changes due to COVID
      - b. Insurance costs going up each year, this year significantly more than the previous year.
      - c. Awards pivot and adjust for the awards for 2020. Thanked Sabrina, Meghann and Clif and Jen Brown for all their work on the awards for outstanding performance and achievements.

- 3. The Strategic Plan 2017 2020 has been pushed out to the end of March 2022 due to the impact of COVID. Going forward Marcus will lead in the 2022-2024 Strategic Plan. Looking forward to that and the engagements with membership in October.
- 4. RJTW welcomed new opportunities for Sabrina's engagement with the Clubs.
- Coach education online with limited technical sessions managed well by Jen. Opportunity to get coach leaders upgraded.
- 6. Officials recruitment redefined the officials development pathway. Looking forward on retention to higher levels
- 7. Welcomed Meghann to Track & Field. Engaging the Clubs and Officials, providing professional development opportunities. Adding expertise to the Throws Project and working with he Track & Field Committee to bring back some important initiatives. Also dipping into facilities review with staff.
- 8. Road & Cross Country was the most severely impacted, having to go virtual. Opportunity to maintain contact with previous and new participants. Partnerships with Triathlon BC for Event Directors seminar which was quite successful. Cross Country camp going ahead in modified format and Whistler 50 hopes to return to in person.
- 9. Through Canada Post Community Foundation grant, para athletics position lead by Katie Miyazaki, engaging Clubs on Para-Athletics in an effort to help support them welcoming to para athletes and expand their capacity as a club.
- 10. Masters Please refer to their report. Records also included. Not able to be represented today at the AGM as the Track & Field Championships are happening today and tomorrow.
- 11. Competitions Introduced, with board approval, membership variances that expanded the participation. Open until the end of the calendar year. Hope to help with club revenue return and assist with increased participation and remove financial barriers.
- 12. Organizational capacity Able to maintain operations in many areas to provide programs and services, in a modified way. Able to retain staff with he federal wage and rent subsidies and recovery grants. Enhanced communication through the e-newsletter. Connected MLAs, Athletics Canada, branches, partners and Provincial agencies. Social media presence took a leap forward. Able to track and report on increased engagements through social media. Clif noted an increased number of subscribers.
- 13. Financial Resources took a hit over the last year. membership dropped 1500 over the last year which was an impact of 54% reduction on the membership revenue. Over the last fiscal, drop of 56% revenue but able to reduce expenditures by 42% (ex. national championships in 2021 due to travel restrictions). BC Government/viaSport Local Sport Relief Fund provided support, most recently with the viaSport Amateur Sport League/Series providing support to the BC Super Series and the Vancouver Island and Interior Road Running Series. Secured other grants to offset resources. Opportunities and funding were critical to helping Clubs and BC Athletics.
- 14. Strategic Plan Planned membership engagement October 13th and 27th, 2021.
- 15. Anticipate full throttle movement forward in 2022. Waiting to see case number drop again, but will need to dedicate time to reconnect with program partners and sponsors. Federal and Provincial governments will continue to be key partners. However core funding and gaming grants need to have a degree of caution and expectation as not sure where going in 2022 and beyond. Will be a three to four year recovery process to get back to pre COVID.
- 16. Infrastructure opportunity during covid for communities to do upgrading and enhancements.
- 17. Continue to enhance communication.
- 18. Thanks to the membership individuals and Clubs, Coaches, Officials, BC Athletics Committees, Board of Directors, Event Organizers, Sponsors, Parents & Volunteers. Your patience is greatly appreciated.
- Sincere thanks to Sam Collier, Jen Brown, Chris Winter, Megann VanderVliet, Katie Miyazaki, Richard Lee, Sabrina Nettey, Clif Cunningham and the summer staff - Jennifer Erickson and Kaleigh Churchmuch.

### a. Post Secondary Club Membership - Team Roster Memberships

(Laurier Primeau/Hilary Stellingwerff) BE IT RESOLVED THAT "ATHLETICS POST-SECONDARY (SCHOOL) AFFILIATE MEMBERSHIP BE AMENDED AND THAT THIS CLUB MEMBERSHIP TYPE BE SET UP TO BE ALIGNED WITH THE CURRENT "SCHOOL CLUB" AND "SCHOOL DISTRICT" MEMBERSHIPS:

- ATHLETES ON THE UNIVERSITY TRACK & FIELD TEAM ARE PERMITTED TO TAKE PART IN BC ATHLETICS SANCTIONED EVENTS WHEN THEY ARE ENTERED INTO AN EVENT BY THE UNIVERSITY.
- THE PERIOD OF VALID ENTRY FOR UNIVERSITY ATHLETES IS FROM SEPTEMBER 1ST THROUGH TO MAY 30TH.
- ATHLETES ARE NOT REQUIRED TO PAY THE \$3.00 SCHOOL STUDENT DAY OF EVENT MEMBERSHIP FEE
- ATHLETE PERFORMANCES ARE NOT RECOGNIZED FOR RANKINGS, TEAM SELECTIONS, RECORDS, SERVICES, FINANCIAL SUPPORT AND OTHER BENEFITS ASSOCIATED WITH A COMPETITIVE ATHLETE MEMBERSHIP.
- ATHLETES WHO WISH TO HAVE THEIR PERFORMANCES RECOGNIZED FOR RANKINGS, TEAM SELECTION, SERVICES, FINANCIAL SUPPORT AND OTHER BENEFITS WILL BE REQUIRED TO TAKE OUT A BC ATHLETICS COMPETITIVE ATHLETE MEMBERSHIP.

### PROPOSED AMENDEMENTS:

- THE POST-SECONDARY CLUB MEMBERSHIP FEE BE: \$250.00 PER YEAR + GST
- ALL POST-SECONDARY CLUB COACHES MUST BE ANNUAL COACH MEMBERS OF BC ATHLETICS
- WHEN ENTERING A BC ATHLETICS SANCTIONED COMPETITION THE POST-SECONDARY
  TEAM, WHO ARE NOT COMPETITIVE ATHLETE MEMBERS OF BC ATHLETICS OR ANOTHER
  ATHLETICS CANADA PROVINCIAL/TERRITORIAL BRANCH MMBERS OR A NATIONAL
  ATHLETICS FEDERATION, PAY A \$3.00 BC ATHLETICS DAY OF EVENT MEMBERSHIP FEE.
- It was noted that Post Secondary Clubs will have one vote at the Annual General Meeting and Special Meetings of BC Athletics. It was also noted that the Mover and Seconder of this motion have provided feedback on the amendments and that the BC Athletics Board of Directors supports the intent of this motion and the amendments as outlined.
- Laurier noted that the motion represents UBC, University of Victoria, Trinity University and UBCO, but not Simon Fraser University, so not for all universities. Laurier provided further background for the resolution and noted that many are full members so this would not affect them as they would continue to pay full membership fees. This was to be more in line with what high schools pay.
- Greg White highlighted the proposed amendments and Laurier noted Brian emailed the amendments to both Laurier and Hilary and they were in agreement. It was confirmed that the amendments had been taken into account for the current resolution being proposed.
- Question was asked if the school membership allows for ranking. Laurier clarified it does not, and those university athletes who want rankings will have to purchase a full competitive membership.

Vote was called on the motion for the amended resolution Vote was passed by the delegates. CARRIED

### b. Entry Fees: BC Athletics Championship and Owned Events

(Greg White/Marcus Wong) BE IT RESOLVED THAT THE ENTRY FEE FOR ALL BC ATHLETICS CHAMPIONSHIPS (TRACK & FIELD AND CROSS COUNTRY) AND ASSOCIATION OWNED EVENTS BF:

- INCREASED BY \$5.00 FOR THE 1ST EVENT ENTERED; AND
- THAT ALL OTHER EVENTS BE THE REGULAR ENTRY FEE (NOTE: DOES NOT APPLY TO RELAY EVENTS); AND
- THAT ALL REVENUE GENERATED THROUGH THE \$5.00 FEE BE USED TO SUPPORT BC ATHLETICS OFFICIALS DEVELOPMENT PROGRAM THROUGH THE PROVISION OF

DEDICATED STAFF TO WORK WITH THE OFFICIALS COMMITTEE FOR THE RECRUITMENT, TRAINING, DEVELOPMENT AND RETENTION OF OFFICIALS; AND BE IT RESOLVED THAT:

- FOR BC ATHLETICS ROAD RUNNING CHAMPIONSHIPS AND ALL OTHER NON-STADIA BC ATHLETICS CHAMPIONSHIP AS MAY BE DEVELOPED THAT CONSULTATION WITH THE BC ATHLETICS ROAD RUNNING COMMITTEE AND OTHERS AS DETERMINED, BE UNDERTAKEN TO CONSIDER THIS PROPOSAL.
- It was noted that the Board of Directors recommends support for this rule change.

(Greg White/Jim Hinze) BE IT RESOLVED THAT THE INTERPRETATION OF AFFILIATED CLUBS BE AMENDED TO BE:

"AFFILIATED CLUB" MEANS ANY ATHLETIC CLUB OR ORGANIZATION WIHIN THE PROVINCE OF BRITISH COLUMBIA RECOGNIZED BY THE SOCIETY AS HAVING A MEMBERSHIP CONSISTING OF AT LEAST FIVE REGISTERED MEMBERS;

- It was noted that the Board of Directors recommends support for this by-law amendment.
- Brian McCalder noted the bylaw amendment requires 2/3 approval (54 votes in favour).
- There were no comments or questions from the delegates.

Vote was passed by the delegates. CARRIED

### e. BC Athletics Hall of Fame - Masters Eligibility

(Jake Madderom/Harold Morioka) BE IT RESOLVED THAT THE CURRENT CRITERIA BE AMENDED TO READ:

"MASTERS ATHLETES WHO HAVE HAD OUTSTANDING ATHLETICS PERFORMANCES OVER A PERIOD OF AT LEAST 10 YEARS AND WHO HAVE BEEN BC ATHLETICS MEMBERS FOR A MINIMUM OF 10 YEARS, WILL BE CONSIDERED FOR NOMINATION TO THE BC ATHLETICS HALL OF FAME WHEN:

- THEY ARE OVER THE AGE OF 65; OR
- THEY HAVE BEEN RETIRED FROM MASTERS NATIONAL OR INTERNATIONAL ATHLETICS COMPETITION FOR AT LEAST 5 YEARS; OR
- THEY ARE DECEASED"

- As question was asked if the 10 years has to be in masters competitions and it was clarified that no, it's 10 years as a masters member.
