## 2. BC Athletics Discipline Hearing and Discipline Panel Recommendations – Brian McCalder

On Monday, July 29<sup>th</sup>, 2019 a BC Athletics Discipline Panel convened to discuss and consider the formal complaint against a 2019 member of BC Athletics on allegations of verbally abusive comments made by the member at the 2019 BC Athletics Masters Track & Field Championships held in conjunction with the 2019 Langley Pacific Invitational Track & Field Meet, June 14 16 to BC Athletics Track & Field Official(s) and Langley Mustangs volunteers at the Athlete Control/Check-in Tent.
- b. The BC Athletics Discipline Panel was Jim Hinze, John Bird, Jake Madderom and Greg White, Chair.
- c. Information for the BC Athletics Discipline Committee Hearing and Appeals Process Circulated
- d. Information considered by the BC Athletics Discipline Panel Circulated
  - The Panel discussed and considered all the information provided and determined that the respondent did contravene the BC Athletics Codes of Conduct - Athletes Code of Conduct - Items 9, 10, 12; and Coaches Code of Conduct - Items 3.g.

  - iii. That letters of apology be sent from the member to the Langley Mustangs Track & Field Club, with a copy to the BC Athletics Board of Directors; and the BC Athletics Officials Committee, with a copy to the BC Athletics Board of Directors.
  - iv. That notification of the suspension and denial of membership as set out be communicated to Athletics Canada, Canadian Masters Athletics (CMA) and Greyhounds Track & Field Club.
  - v. Motion to approve the decision of the Discipline Panel as presented
