### IAAF becomes World Athletics.

If you follow international athletics news and gossip you have probably noticed a change “at the top”. The IAAF is no more. The international body for “Athletics” has a new look and a new name..... World Athletics.

The updated [Competition Rules](#) (2020-2021) are freely available as a download, and have been extensively re-organized. The bad news is that they are still hard to find on their web site, buried on the third layer of [Worldathletics.org](http://Worldathletics.org) under [Competitions/Our Sport/Rules and Regulations].

The re-organization.

Competition Rules and Technical Rules have been folded into a larger publication, the Book of Rules, where they form 2 chapters of Book C. The rules we normally use have been distributed into these 2 separate sections, and given new numbers. Each Rule shows both the old number and the new number. It may be that the old numbers will pass out of use in the next edition.

Chapter 1 (of Book C) Competition Rules (C1.1 to C31)

This includes old rules 2 (Authorization to stage competitions) to 137 (Advertising Commissioner) and Rules 260-265 (World Records)

Chapter 2 (of Book C) Technical Rules (C2.1 to C2.57)

This includes old rules 100 (General Technical Rules) and 140 (The Athletics Facility) to 251 (Mountain and Trail Races).

Taken together the 2 new chapters add up to 180 pages, considerably slimmer than the [Competition Rules 2018-2019](#). Field of Play officials may be able to do without the other content of Chapter 3:

- Health Medical and Welfare
- Athletes' Representatives
- Event Bidding
- Marketing and Advertising

Officials will have to read the new book(s) with close attention:

- New text is no longer indicated with double vertical lines to bring it to your attention... you have to find it for yourself
- Green notes (explications) from the previous edition are, in some cases, brought forward intact and without revision, but some may have been dropped.
- Other green notes are revised or new.... you have to find these for yourself.

### The National Mentoring Program

*\*If, like me, you haven't done this yet, do it today\**

The Officials Committee is working on the integration of the recruitment and mentoring processes with a view to having mentors trained and in place for the start of the 2020 outdoor season. Those interested in mentoring, should complete the checklist available on the Officials website under Newsletters and Meetings and submit to [brian.thomson@shaw.ca](mailto:brian.thomson@shaw.ca) by February 15. Note: Mentoring will initially be provided to level 1 and 2 officials before adding in levels 3 to 5. After mentors successfully complete a workshop (estimated at 2 hrs), they will be matched with mentees to start the mentorship.

### Enhancements to Officials Development Pathway

The National Officials Committee (NOC) is enhancing the pathway for development of officials with the goal of every official in Canada receiving the same training and going through the same development activities. The enhancements also streamline the entrance to levels 1 and 2, provide training at every level and reduces the administrative effect in upgrading officials.

The enhancements to level 1 and level 2 are ready to go. Changes include workshops delivered on-line, a mentoring model to provide official specific development and slight reduction but more structure in the experience requirements. Level 1 is targeted at those with no previous exposure to athletics.

Further changes to the development pathway are underway:

- level 3 pathway is currently being developed and should be ready late 2020 or early 2021. Changes include the addition of a workshop to provide training on rules, etc. and the requirement for one evaluation from a trained Provincial Evaluator.
- levels 4 and 5 pathways are at concept stage and will be flushed out later in 2020 or 2021.

The BC Athletics Officials Committee is revising the provincial processes for recruiting and developing officials to accommodate these exciting enhancements. The mentoring program is also being woven into the revised processes. The new pathway for levels 1 and 2, including the mentoring program should be in place well before the start of the 2020 outdoor season.

### **Proposed Officials Development Pathway (December, 2019)**

**Level 1 Official**—Optional. Target those with no prior exposure in athletics:

- Clinic: Online
- Evaluation: N/A
- Experience – 4 events: vertical jumps, horizontal jumps, throws, track.

**Level 2 Official**—assist officiate at meets within region

- Timeframe: one year to completion (including any time at Level 1)
- Clinic: Online with 70% score on online assessment
- Evaluation – done by mentor (1 evaluation)
- Experience –2 sessions (e.g., morning, afternoon) in each of: track, throws, vertical jumps, horizontal jumps

**Level 3 Official (DRAFT)**—able to chief provincial championships and officiate at national championships

- Timeframe: minimum one year from level 2 to completion

- Clinic: face to face workshop in specific discipline (under development). Envisioned to be similar to rules component of current level 4 workshops.
- Exam—70% score.
- Evaluation—by trained Provincial Evaluator (1 evaluation)
- Experience—to be defined.

**Level 4 Official (DRAFT)**—able to chief national championships

- Timeframe: minimum two years from level 3 to completion
- Clinic: face to face workshop in specific discipline (development in late 2020 or 2021)
- Exam—to be determined
- Evaluation—by trained National evaluators (2 evaluations)
- Experience—to be defined.

**Level 5 Official (DRAFT)**—able to chief any meet

- Timeframe: minimum three years from level 4 to completion
- Online module (development in 2021)
- Exam—to be determined.
- Evaluation—by trained National evaluator (2 evaluations)
- Experience—to be defined.

Happy New Year from Universal Athletics to BCA Officials. In appreciation for your support of our efforts over the past years, we wanted to give you some advance information as there will be some changes in Surrey meets for 2020.

1. Universal's Annual Canada Day weekend will NOT be held this year, due to conflicts with the National Championships.
2. UAC has partnered with South Fraser and will be hosting the traditional South Fraser Meets; The Fraser Valley High School Meet on April 11 and the Junior Olympics on May 16. Both meets will be held, as always, at Bear Creek Park. Jessie and I, along with Dave Moore, will be the Meet Director and Manager.

One major change will be the Junior Olympics will be a ONE DAY MEET, on Saturday on the May long weekend. The target participants will be elementary athletes, with a Track Rascal Event mid-day.
