## **Return to Competition**

All Competitions will take place under strict Protocols and Safety Guidelines. Your Officials' Committee along with BC Athletics staff have developed Protocols for each of the Event areas. These were approved by the BCA Board of Directors. No Rule modifications have taken place; however, safety guidelines have been written to ensure that our practices in dealing with all participants in a Competition are clear and provide for health and safety. These guidelines, unfortunately, restrict the numbers of Officials and Volunteers but will still allow results to be valid and all records set by Athletes accepted by accrediting bodies.

It is good practice to build your own PPE Kit to bring with you to any competitions you may attend.



#### Your PPE Kit should include:

- Face masks
- Those Officials who will be in high-contact positions should also consider having goggles or face shields
- Gloves
- Hand sanitizer
- Disinfectant wipes or spray
- Paper Towels

Organizing Committees (HOC) will be responsible for sanitizing all equipment to be used by Athletes and Volunteers (including Officials). Officials should be prepared to monitor their involvement and use items from their own kits as is necessary.

- Awards

Due to the limited number of Competitions being held in 2020, the annual BC Athletics awards for Officials will not be presented for this year. We look forward to a more robust competition year in 2021 and with that return, once again recognizing our wonderful BC Officials who are always so generous with their time.

One of our annual awards is named for an outstanding Official who served our Province so ably and for many years. Louise Meville has written a remembrance of Mary Temple. The Mary Temple Award is presented to a registered Official who, in their first 5 years, has focused substantial effort on learning to be an official as well as contributing willingly and unselfishly as a beginner Official.

#### Mary Temple by Louise Meville

Mary Temple was a long-serving track and field official in BC. She welcomed and encouraged many "newbies" to the sport, and also many parents of track athletes to engage in helping to run the events through their volunteerism. She began as a parent of Irene, a hurdler. A second daughter Fiona was also introduced to officiating for the sport. Together they joined the Kerrisdale Cheetahs Club started by Valerie Jerome and Ron Parker about 1968. She officiated at their meets and worked up her credits, especially in long jump, later in some track events and as Jury. She was the first Officials' Manager that I knew, ensuring officials were invited for meets and maintaining a phone list that I inherited long ago. We did mainly local and BC meets, and national events were later granted to the province starting with the Achilles Indoor Meet (at the PNE Coliseum I believe it was. A formal affair with officials in suits and dresses.) In 1974, group of senior Vancouver officials including Mary, held a workshop, sponsored by the Vancouver Sun paper to ensure that with the upcoming Montreal Olympics, the public could be made aware of the track and field events shown on TV. At that series of workshops, several senior officials gave instruction as to how their individual events were conducted. It was called Olympic Appreciation for track and field. Four of the participants at the workshops stayed on as novice level 1 track and field officials and worked on their credits over the years: Trevor Chu, Louise Meville, Shirley Nelson, and Polly Hlookoff. Mary's encouragement kept us participating for many years at finish line, long jump and throws. When the senior officials left for the practices and the games itself in 1976, we were part of the officials' crew who stayed back to help run the local meets. Noel Marples (Surrey), Mary Temple (Vancouver), Jack Hollands (Nanaimo) with Valerie Jerome (Vancouver) as chief, made up a team for officiating the long and triple jumps for the Olympics. They had previously worked the Summer Games at Swangard in 1973. Mary and her friend from the Kerrisdale Cheetahs, Janet Wood, (clerk of the course in those days) ran the officials' committee for some years. Mary knitted pullover sweaters in the red, white and blue colours of BC track for officials and I still have mine. Mary was instrumental in getting several of us, keen but newer to the sport, an invitation to attend as officials the Commonwealth Games in Edmonton in 1978. We made up a group of officials from each province and some foreign countries to learn the umpiring that we do today, though not on the scale as we did then. It was very strict and formal. We travelled to Edmonton and Calgary ahead of the games to practice this new to us part of the track events. It was a great opportunity that Mary initiated and has kept some of us involved until present day. Mary died of dementia in the mid 1980's and was really missed for her sense of humour, friendly manner, efficient leader of the officials' committee, encouraging nature, and very broad English accent. The Mary Temple Award was given for encouraging new officials to keep in the sport, join the BCTF assoc., and it was awarded annually in her honour. Mary also served on different committees locally and nationally. She was one of the founding members of the Harry Jerome committee responsible for the Harry Jerome statue in Stanley Park. She served that committee as secretary and accountant at its conception. She and Valerie Jerome continued their close relationship over the years; they both worked the long and triple jumps. Between events they could be found together working on cryptic crossword puzzles near the long jump pit. Many of us were encouraged by Mary Temple and have kept in the sport for many years. a) the team would be disqualified (Rule #TR24.11

c) 10cm throughout the competition (Rule #TR39.8.4)
