- Edits to minutes from February 21, 2021 meeting of Officials Committee
 - Committee members asked to confirm acceptance of edits to meeting minutes (via email sent on Sept 12, 2021). No concerns raised in responses.
 - Page 3 (Provisional (in training) Official)—enhancement to the name of an official who hasn't reached level 1. The name reflects what the official is actually doing (training) and is parallel to terminology used in the coaching pathway. Due to the short pathway to Level 1, we do not anticipate many officials with this title.
 - Page 4—changing the decision on when rule books are distributed. Officials will sign-up for pathway to level 2 (on BC Athletics website), pay their \$25 (as per recommendation on June 14) and obtain a rule book. This is similar to the old model where officials took a level 2 workshop, paid their \$25 and received a rule book.
 - 3. Page 5—change name of "Off-Track" to "Road Racing/Cross Country".
