David Weicker is an AITO for NACAC, was a member of the World Athletics (IAAF) Technical Committee and member of the World Athletics (WA) Panel of International Photo Finish Judges. He is a former ITO for WA and has been an international technical official for both able-bodied and para-athletics since 2004.

David is a mentor in Canada as well as being a Certified Master Clinician in Canada. He has been a certified technical official for over 40 years in Canada having also been a coach and administrator subsequent to a successful career as an athlete.
