1. AGM Resolution on Membership Fees

Motion: Approval to present BC Athletics Membership Fee Proposal to the membership at the 2013 BC Athletics Annual General Meeting:

- 1. That BC Athletics approve the Athletics Canada membership fee increase of \$10.00.
 - a. This increase to \$15 per individual member would result in an annual fee based on:
 - i. 2013 total Individual Membership of 5,305 x \$15.00 = \$79,575
 - b. The current amount paid @ \$5.00 per individual member: 5,305 x \$5.00 = \$26,525
 - c. Balance to generate: \$79,575 \$26,525 = \$53,050
- 2. That the increased membership fee be shared through the following means:
 - Sanctioned Event Entrants Fee a component of the Post Event Remittance process be increased by \$.10 per Event Entrant to a total of \$.15 per entrant.

- This would generate \$15,000 based on the current tracking of 150,000 Event Entrants in BC Athletics sanctioned events;
 - 1. The current amount generated by this portion of the Post Event Remittance process is \$5,000.
- b. That the BC Athletics Annual Club Membership Fee for renewing clubs be increased to \$250. New clubs would have a one time 50% promotional discount in their joining year.
 - i. This flat fee of \$250.00 would currently be equal to the Annual Liability Insurance Premium per Club paid by BC Athletics.
 - ii. This would generate \$19,250 based on the current number of Clubs (77) registered with BC Athletics – inclusive of the Community, Society and Post-Secondary Club membership types.
 - 1. The current BCA Club Membership fee structure generates \$11,300
- c. BC Athletics Sanctioning Fees Club and Non-Club Member Event Sanction Fees
