Over these past five months, the Board of Directors, which were scheduled to meet just two times, have met six times by teleconference or electronically. The decision of the Board was to continue operations and support the membership, understanding that the last five months has been a challenge for our BC Health Officials, the BC Athletics Clubs, Members, Officials, Board of Directors and our BC Athletics Staff.
