### 1. Changes to Fee Schedule for Officials

### Changes to membership fees discussion

Current situation:

- Currently \$15, all goes to Athletics Canada, no portion of fees retained in BC Athletics.
- Committee continues to spend over budget and dip into donations (deferred revenue) account, will run out in a few years.
- Rising costs—due to aging demographics of officials, we will need to develop younger
  officials to fill their place. Resulting in an anticipated increase in expenditures for
  travel—to obtain experience at meets in BC and out of province for evaluations (levels
  3-5).
- Modernizing officiating in BC and Canada—a new certification pathway is a stimulus for changing fees. Signaling and supporting a new model and way of administering our officiating programs.

### Options to address current situation:

- 1. No change—use donations (deferred revenue) to cover short falls until donation account runs out.
- 2. Ask BC Athletics Board to implement meet sanctioning fees, or day of event surcharges, to cover membership fees and other officiating expenses as per models used in other provinces.

- 3. Scale back expenditures
- 4. Increase membership fees for officials.

### Changes to fees for certification pathway

Discussion ranged from cost recovery-based fee model to value-based fee model.

Side discussion about providing rule books to officials on pathway to Level 2 (i.e., completed online module and worked one meet). If they get a rule book – may never use the rule book as an official.

#### **Recommendations to BC Athletics Board**

- 1. **Motion 1**—current fee structure maintained effective for 2022. As per attached recommendations document:
  - a. Pathway to Level 1—no charge
  - b. Pathway to Level 2--\$25.
  - c. Pathway to levels 3-5 will be determined when pathway finalized.
- 2. **Motion 2**—additional revenue from fee increases will be added to the Officials Committee budget for use in programs to recruit, develop, and retain officials.
- 3. **Motion 3**—membership fees for officials be increased by \$10-15 (ask BC Athletics Board for direction on financial impact) effective for 2023—to give clubs and officials a year to resume operations after COVID impact.

### **VOTE** on recommendations (motions) to BC Athletics Board (above)

- Motion 1—11 in favour.
- Motion 2—11 in favour.
- Motion 3—10 in favour; one against.

## 2. Changes to Nomination Criteria for BC Athletics Awards for Officials

# **Summary:**

The BC Athletics Officials Committee recommends the following changes to the fee schedule for officials:

Increase fees for official's membership in BC Athletics.

Additional revenue required to reflect officiating fees paid to Athletics Canada by BC Athletics; and new recruitment and development tools and procedures from the National Officials Committee (enhanced certification pathway). These enhanced recruitment and development tools and procedures require additional revenue to cover anticipated expenditures in development of officials (e.g., travel expenses for experience and evaluations, workshop facilities and clinicians for levels 3-5).

## Reflect value in enhanced certification pathway

The enhanced certification pathway modernizes the training and development program for officials. Training is provided at every level along with experience opportunities at a wide range of meets, and mentoring programs to assist officials become the best they can be.



## Upgrading to Levels 3-5

NOC starting to resume evaluations of officials upgrading to Levels 3-5 after delays dues to COVID-19. One evaluation of BC official conducted in June.

## Discipline Specific Mentoring Program (NOC)

Several BC officials are leading some of the mentoring groups in NOC's new discipline specific mentoring program (e.g., Starter's Assistant, Horizontal Jumps).

# Electronic Distance Measuring (EDM) Training

Delivered 7 sessions to 27 participants in Lower Mainland on using EDM equipment to measure throws. In preparation for Canadian T&F Championships in 2022/23. Use of EDM successfully implemented at Lower Mainland Meets.
