- 5.3 a) The Board of Directors shall consist of fifteen Directors including the Past Chair who shall have voting privileges for the first year following the election of the new Chair.
- 5.3 b) All Directors shall be elected by elected position representing: Chair, Vice Chair, Director Finance, Director Marketing & Communications, Director Administration & Planning, Director Programs & Technical Development, Director Events & Promotions, Director Zones 1 and 2, Director Zone 6, Director Zones 7 and 8 and two Directors from a combination of Zones 3, 4 and 5 and two Athlete Representative Directors who shall be elected by members of BC Senior and Junior Teams.
