4.9 **RESOLUTIONS** - A list of Resolutions, each including a Whereas, and other information was circulated for consideration.

1. Calendar of Events – Event Listing Fee.

Be it resolved that in order to create a more comprehensive calendar of events, these fees will no longer apply and therefore all BCA calendar listings will be free of charge with live race website links given only to BCA Sanctioned

- The Executive does not support this resolution and recommends it be Withdrawn since the listing fees have been suspended for 2008. During the year the Policy will be reviewed.

2. Publishing of the Calendar of Events

Be it resolved that the Online Calendar of Events replace the published book, similar to the way the BCA Bulletin replaced the BC Athletics Record. The electronic calendar can be updated daily, as new fixtures are introduced as data is modified for existing events. The electronic calendar can also have live links to websites, online registration systems and Race Directors' e-mail addresses for all sanctioned events, simplifying the process for all runners seeking race information. For those few BCA members that do not have communication computer, BCA staff can download and print the electronic event listing and mail it to these access to a members on request. BCA staff should endeavor to have the Online Calendar of Events available on January 1 of each year and should maintain and amend the electronic file throughout the year as changes and updates are

3. Eligibility for Championship Medals

Be it resolved that eligibility for medals in the BC Championship Road Running Races be extended to BC Athletics members of any membership type including DOE members, but that BC Athletics prize money only be winners who have an athletic membership in BCA. awarded to

4.BC Athletics 8 km Road Running Championship

Be it resolved that under Section 5.1 of the Rules and Regulations, 8K will replace 20K as an official provincial Championship distance

- -The Executive does not support this resolution as worded and recommends it be amended to read:
- "That an 8K Race be added as an official Road Running Championship distance."

5. Masters Series Events – age category determination for Masters

Be it resolved that regulation 5.6.b and 8.5.b be amended to read: for a series of races, it is recommended that age group be determined by age at the final event of the series.

- -The Executive recommends that this resolution be Tabled and referred to the BCA Masters Committee for recommendation to the Board.
- 6. Masters Age Eligibility for: a) BC Athletics Masters Road Running Championships Awards
 - b) BC Athletics Master Road Running Teams
 - c) BC Athletics Masters Annual Road Running Awards

Be it resolved that for BC Road Running Championships, Masters Awards only be made to athletes aged 40-plus, and that selection to any BC Masters Road Running Team, or eligibility for Annual Masters Road Running be limited to athletes aged 40-plus; and Be it resolved that BC Athletics' Athletics Canada

representatives make a similar resolution at the next Athletics Canada AGM.

- The Executive does not support this resolution. Since BCA is compliant with Athletics Canada and IAAF this resolution would discriminate against official age 35-39 Masters.

- A questions arose re: the motion submitted; therefore, it was recommended that Tom Hastie discuss the wording the motion with George Gluppe and then re-submit it to the BCA Office for presentation at the 2008 AGM. of
