In Progress

- Annual Report
 - It was suggested that we use people outside of the Committee to tackle some of the tasks
 - Outstanding Issues and Concerns
 - Harassment and Abuse
 - We require BC Athletics to take a position on this matter.
 We believe that Denise Clements was to head a BCA
 Committee looking into this issue. We will contact BCA
 with a request to move this issue forward.

Bill

- Criminal Record Checks
 - Those completed are valid for 5 years from date of application
 - All new Officials will require these checks
- Branch Statistics
 - The apparent decrease in total numbers of Officials may be because a number of active Officials fail to re-register. Inquire at BCA whether it is possible for them to send out automatic reminders to individuals about the need to re-register.

Carol

- Mentorship
 - 35 Mentorships were completed this year.
 - Many Officials fail to respond to Bill Koch (Mentor and Training Coordinator) regarding mentorships or assignments as mentors.
 - It will be a future requirement that, once completed, a copy of the mentoring/evaluation report will be sent to Bill. To this effect, a note on the Provincial Mentoring Form will be made. It is suggested that a similar note be placed on the forms distributed by NOC.

John

- The Final Draft of the Annual Report will be completed very soon.
 Committee members should send additional suggestions to John ASAP.
- Webpage
 - The webpage needs to be reorganized for legibility, clarity and ease of use (see draft of redesign).

John

- Seniors' Games Kamloops 2013
 - John Cull, Al McLeod and Harold Morioka will act as advisors for the next Games.

Planning Discussion

- BCA Membership Survey
 - Communication. It is significant that a large number of respondents indicated their preferred method of communication was via e-mail. It is important to remember that preference for communicating via Face Book and Twitter is growing, particularly among younger members.
 - Explore further the desirability of Officials affiliating or reaching out to specific Clubs.
 - There is continued concern about accessibility of workshops for Officials in more rural or remote areas of the Province. Also of importance is the need to develop greater involvement of Officials who reside in these areas.
 - Explore the feasibility of creating an 'On-Line' Level 1 Officials'
 Workshop. Our continuing goal will be to have a Level 1 instructor living within close proximity (1 day for travel and course presentation) of a community or individual interested in taking a course.
 - An objective for 2013 will be to pursue the creation and use of a promotional film or power point presentation.
- Strategic Planning Meeting
 - This was a Meeting organized by BCA and held on August 11th and 12th of 2012. The Strategic Plan encompasses an 8-year vision with an initial 4-year plan. Those attending were representatives of BCA stakeholders. See Strategic Planning Meeting report.
 - It will, in future, be important to address the Officials' report in a format that aligns with 'The Pillars' (key strategic areas).
- Future Meetings
 - 4 full meetings per year

 - It was decided that the first meeting following the AGM should be faceto-face to allow new Committee members to become acquainted with those serving their second terms.

Defeated

- The February 2013 Meeting will be held as a teleconference (this will be a trial as to the effectiveness and workability of such a format). If successful, there is the possibility that other full meetings be held in this manner. There is also the option of having 2 or 3 individuals from the Committee attend other meetings by teleconference. On call of the Chair, meetings held on specific topics may also be held by teleconference (these meetings may not include all Committee members).
- It was suggested that a member be appointed to look into the viability of 'Desktop Conferencing'.
- Action Plan based on Officials' Survey (Laurel)
 - o It is vital that the Committee members' should represent a Provincial rather than simply a regional perspective.
 - There needs to be a greater emphasis on the movement of Officials throughout the Province to attend Meets not just of Officials from the North, Island and Interior coming into the Lower Mainland.
